**OPENING DATE:** Immediately **CLOSING DATE:** May 3<sup>rd</sup>, 2024

**ENTRIES **MUST BE RECEIVED** NO LATER THAN May 3<sup>rd</sup>, 2024, or late fees will apply. Entries must be in writing and accompanied by a check to be scheduled. If your WRITTEN entry is not received by the closing date you may not be scheduled. Enter early to be assured of a place. If show is oversubscribed, entries will be assessed according to post mark and put on a waiting list. We reserve the right to close entries early if available judge time/daylight is exceeded. A current negative Coggins test must accompany your entry. You will not be allowed on the showgrounds without it!**

**ATTIRE:** Casual and tidy with hard soled shoes. Helmet required by ALL competitors when mounted.

**DRESSAGE SCHOOLING:** Available Friday (and Saturday after dressage show if time allows). Rings will be set, watered, and dragged by 1pm on Friday 10<sup>TH</sup>. You are welcome to school earlier but be aware that show management may still be watering and/or dragging.

## **DRESSAGE SHOW**

**OFFICE FEE:** \$15 (mandatory – all entries)

**NON-SHOWING HORSE:** \$25.00

**DOGS:** If you bring them, they must be of a pleasant nature and please ensure they are leashed. **STABLING:**

Overnight \$35.00 (per night)

**SHAVINGS:** \$10.00 per bag

**GROUNDS FEE:** \$25.00 (if not stabled)

**CAMPER SPACE:** \$30.00 per day

**CLASS FEES:** \$35 per class. **LATE FEE \$5/CLASS.**

**SEDA QUALIFICATION \$10/CLASS. PLEASE WRITE SEPARATE CHECK MADE PAYABLE TO SEDA**

**Maximum of 3 classes per day per horse.**

**PRIZES:** Ribbons awarded for 1st through 6th place

**LEVELS -** Introductory through Grand Prix.

**RIDE TIMES:** Please contact Judi Dauterive after May 8<sup>th</sup> (O: 985 796 3712 cell: 504 453 1791). If you provide an email address, times will be emailed to you. No postcards will be sent.

**REFUNDS: Absolutely no refunds FOR ANY REASON after closing date. REFUNDS REQUESTED BEFORE CLOSING DATE WILL BE ISSUED MINUS OFFICE FEE.**

**ENTER EARLY TO BE ASSURED A PLACE!** If the show is over subscribed, entries will be assessed according to post mark and put on a waiting list.

This show is SEDA recognized. Points/scores earned by event participants may be submitted for the SEDA Year-End Awards. Schooling dressage only test sheets should be retained to send in at the end of the year as per the SEDA schooling dressage awards guidelines.

ASTM hard hats required when mounted. USDF: junior is under 21 on day of show.
