ENTRIES **MUST BE RECEIVED NO LATER THAN September 16th, 2022** or late fees will apply. Entries **must be in writing and accompanied by a check** to be scheduled. If your WRITTEN entry is not received by the closing date you may not be scheduled. Enter early to be assured of a place. If show is oversubscribed, entries will be assessed according to post mark and put on a waiting list. We reserve the right to close entries early if available judge time/daylight is exceeded.

A current negative Coggins test must accompany your entry. You will not be allowed on the showgrounds without it!

COVID-19: We do ask competitors to maintain social distancing in barns and by arenas Please be sure you have a perfect entry since interaction with the office staff will be limited and the office closed to all but necessary officials. Bridle numbers will be placed on stall doors. ONCE TESTS ARE SCORED, THEY WILL BE AVAILABLE FOR PICK UP OUTSIDE THE OFFICE. Please do not enter the showgrounds if you are exhibiting any symptoms of Covid-19 or have recently been exposed.

ATTIRE: Casual and tidy with hard soled shoes. ATSM Helmet required by ALL competitors while mounted.

TACK: As per USEF rules for your dressage discipline and level.

SCHOOLING: Available Friday (and Saturday after show if time allows). Rings will be set, watered and dragged by 1pm. You are welcome to school earlier but be aware that show management may still be watering and/or dragging.

NON-SHOWING HORSE: \$25.00

DOGS: If you must bring them, they should be of a pleasant nature and please ensure they are leashed at ALL times.

STABLING: Overnight \$30.00 (per night)

SHAVINGS: \$10.00 per bag

GROUND FEE: \$25.00 (if not stabled)

CAMPER SPACE: \$30.00 per day

CLASS FEES: \$30 per class. **LATE FEE \$5/CLASS.** Maximum of 3 classes per day per horse.

OFFICE FEE: \$10 per entry

PRIZES: Ribbons awarded for 1st through 6th place

This show is a qualifier for the SEDA 2021 Schooling Dressage Championship to be held January 2023. If you are riding the highest test of your level and want it to count as a qualifier, you must pay the qualification fee PRIOR to your ride.
