OPENING DATE: Immediately CLOSING DATE: September 11th, 2026, ENTRIES **MUST BE RECEIVED** NO LATER THAN September 11th, 2026, or late fees will apply. Entries must be in writing and accompanied by a check to be scheduled. If your WRITTEN entry is not received by the closing date you may not be scheduled. Enter early to be assured of a place. If show is oversubscribed, entries will be assessed according to post mark and put on a waiting list. We reserve the right to close entries early if available judge time/daylight is exceeded. A current negative Coggins test must accompany your entry. You will not be allowed on the showgrounds without it!

ATTIRE: Casual and tidy with hard soled shoes. Helmet required by ALL competitors when mounted.

DRESSAGE SCHOOLING: Available Friday (and Saturday after dressage show if time allows). Rings will be set, watered and dragged by 1pm on Friday 19th. You are welcome to school earlier but be aware that show management may still be watering and/or dragging.

DRESSAGE SHOW

OFFICE FEE: \$20 (mandatory – all entries)

NON-SHOWING HORSE: \$30.00

DOGS: If you bring them, they must be of a pleasant nature and please ensure they are leashed.

STABLING: Overnight \$35.00 (per night)

TACK STALL: \$30.00 (per night)

SHAVINGS: \$10.00 per bag

GROUND FEE: \$30.00 (if not stabled)

CAMPER SPACE: \$30.00 per day

CLASS FEES: \$35 per class. LATE FEE \$5/CLASS.

SEDA QUALIFICATION \$10/CLASS. PLEASE WRITE SEPARATE CHECK MADE PAYABLE TO SEDA

Maximum of 3 classes per day per horse.

PRIZES: Ribbons awarded for 1st through 6th place

LEVELS - Introductory through Grand Prix.

If you provide an email address, times will be emailed to you. No postcards will be sent.

REFUNDS: Absolutely no refunds FOR ANY REASON after closing date. REFUNDS REQUESTED BEFORE CLOSING DATE WILL BE ISSUED MINUS OFFICE FEE.

ENTER EARLY TO BE ASSURED A PLACE! If the show is oversubscribed, entries will be assessed according to post mark and put on a waiting list.

This show is SEDA recognized. Points/scores earned by event participants may be submitted for the SEDA Year-End Awards. Schooling dressage only test sheets should be retained to send in at the end of the year as per the SEDA schooling dressage awards guidelines.

ASTM hard hats are required when mounted. USDF: Juniors are under 21 on day of show.

This show is a qualifier for the SEDA 2026 Schooling Dressage Championship to be held in February 2027. If you are riding the highest test of your level, you must pay the qualification fee prior to your ride if you want it included.
