ENTRIES MUST BE RECEIVED NO LATER THAN January 30th 2026 or late fees will apply. Entries must be in writing and accompanied by a check to be scheduled. If your **WRITTEN & PAID** entry is not received by the closing date you may not be scheduled. Enter early to be assured of a place. If the show is oversubscribed, entries will be assessed according to post mark and put on a waiting list. You may email your entry to ponyparade@hotmail.com and pay by PayPal (\$5 fee). **We reserve the right to close entries early if available judge time/daylight is exceeded. Complete entries will be given precedence over incomplete entries.**

A current negative Coggins test must accompany your entry. You will not be allowed on the showgrounds without it!

There will be **NO** jump schooling on Friday or Saturday.

ATTIRE: Casual and tidy with hard soled shoes. Helmet required by ALL competitors when mounted, with chin strap fitted snugly. Glittermarx are permitted.

DRESSAGE SCHOOLING: Available Friday (and Saturday after the show if available light permits). Rings will be set, watered, and dragged by Friday 1pm. You are welcome to school earlier but be aware that show management may still be watering and/or dragging. CT competitors **ARE** allowed to school in the dressage only competition ring on schooling days.

OFFICE FEE: \$20 per entry – mandatory for all entries.

NON-SHOWING HORSE: \$30.00 Please fill out a separate entry form for non-show horses.

STABLING: \$35.00 (per night)

TACK STALL: \$30 (per night)

SHAVINGS: \$10.00 per bag

GROUND FEE: \$25.00 (if not stabled)

CAMPER SPACE: \$30.00 per day

INCOMPLETE ENTRY FEE \$10 (missing payment, Coggins etc. If missing items are not received by closing date.)

CLASS FEES: Dressage only \$35 per class. **LATE FEE \$5/CLASS.** Maximum of 3 classes per horse.

Combined Test - \$90 per division. **LATE FEE \$10/DIVISION.** Maximum of 2 divisions per horse.

PAYPAL FEE \$5 PER ENTRY (If not paying by check or cash.)

PRIZES: Ribbons awarded for 1st through 6th place

LEVELS: DRESSAGE - Introductory--Grand Prix.

CT – Pre-Mini-amoeba--Training

No postcards will be sent.

DOGS: If you bring them, they must be of a pleasant nature and please ensure they are leashed.

REFUNDS: Absolutely no refunds **after** the closing date for any reason. Refunds requested before the closing date will be issued minus the office fee.

All dressage tests Training level 2 and above will be ridden in the 20x 60m arena. Training level test 1 will be offered in both regular and small arena. USEA classes (unless specified otherwise in test or at rider's request) will be ridden in a 20x40m arena. You may ride Intro tests in the 20 x 60 arena upon request.

Western will be ridden in the arena specified in the test. If size not specified by test or rider, it will be at manager's discretion.

The entire CT will go on SUNDAY. THE CT WILL BE LIMITED TO 55 RIDES.

This show is SEDA recognized. Points/scores earned by event participants may be submitted for the SEDA Year-End Awards. Copies of CT scores from this show must be mailed to the appropriate chairperson within 30 days of the show date for scores to be included in the SEDA Year-End Awards program. Schooling dressage only test sheets should be retained to send in at the end of the year as per the SEDA schooling dressage awards guidelines.

ASTM hard hats are required when mounted. Chin straps to be fitted snugly. Use of a protective vest strongly suggested for stadium jumping. Medical armband recommended for jumping. No test callers permitted in CT dressage.

USDF: Junior is under 21 on the day of show. Dressage only show.

USEA: Junior is under 18 on day of show. Combined test.

*This show is a qualifier for the SEDA 2026 Schooling Dressage Championship to be held in January 2027. If you have not yet qualified and want the ride included, you must ride the highest test of the level and pay the \$10 qualification fee prior to your ride.

We strongly suggest you take your horse's temperature before loading up. If it is above 101.5° F, please stay home.
